BACKGROUND

Section 42-340 of the law requires that the Government Law Center of Albany Law School submit quarterly reports containing "statistics and summaries of citizen complaints, including a comparison of the [Board's] findings with the final determinations of the [Police] Department," on behalf of the Board. This is the fourth quarterly report so submitted in the year 2003.

INTRODUCTION

The Government Law Center of Albany Law School was retained by the City of Albany to provide a number of services to the Board, the City, and the Community with respect to the Board. Many of these are discussed, as appropriate, below.

In general, the following occurred during the fourth quarter of 2003:

• Pursuant to the Board's Operating Procedures (Section II, Review of Complaints, Subsection I), each of the appointed members of the Committee on Complaint Review, in addition to the Chair of the committee, was responsible for presenting at least one complaint at each meeting where Board business was conducted. Ten (10) complaints were presented and reviewed during the fourth quarter. The following Board members served on the committee:

September 2003 Barbara Gaige, Marilyn Hammond, Judith Mazza, Herman Thomas, and Michael Whiteman.

October 2003 Barbara Gaige and Judith Mazza.

- On October 6, 2003, Chairman Kenneth Cox met with Complainant No. 22-02/OPS No. C02-215 to allow her an opportunity to express her concerns regarding the Board's findings as to the allegations contained in her complaint, and to explain the Board's process of review and deliberation of a complaint investigation.
- Following a suggestion made during an outreach meeting with the Center for Law and Justice, the Board voted unanimously to add a new item, "Policy Review/Recommendations," to its monthly meeting agenda. This portion of the agenda will be devoted to discussion of Board policy recommendations and/or requests for policy review.
- At the Board's October 13, 2003 meeting, a new committee, the Policy Review/Recommendations Committee, was formed by Chairman Kenneth Cox. The committee was created for the purpose of addressing and following up on the Board's policy recommendations and requests for policy review. The following members volunteered, and were appointed, to serve on the committee: Barbara Gaige, Judith Mazza, and Paul Weafer.
- During the fourth quarter, the Board voted unanimously to approve the following:
 - its third quarterly report for 2003;

- draft correspondence to Commissioner of Public Safety John Nielsen following up on Board Resolution No. 1 of 2001 and the Board's recommendation for the implementation of a bias-based policing policy by the Albany Police Department;
- draft correspondence to Complainant 1-01 in response to the complainant's request for documents relating to his complaint; and
- revised correspondence sent to complainants notifying them of the outcome of the Board's deliberation of the investigation of their complaint and the findings rendered by the Board.
- The Board met three times during the fourth quarter. Meetings were held on August 19, 2003, September 8, 2003, and October 13, 2003. The August meeting was held at the Albany Community Development Agency on Henry Johnson Boulevard, and the September and October meetings were held at the Albany Public Library on Washington Avenue. There was a public comment period at each meeting, and the September and October meetings largely consisted of the review of complaints.
- The Board continues to meet on the second Monday of every month so as not to conflict with the monthly meetings of the Common Council, and to encourage media participation at Board meetings. The Board will continue its 6:00 p.m. meeting time for the remainder of 2003. Meetings will continue to be held at the Albany Public Library on Washington Avenue when space is available. The Community Room at 200 Henry Johnson Boulevard remains the primary alternate meeting location.

Training

Section 42-339 of the City Code requires that "the Government Law Center . . . provide, to CPRB members, and the members shall undergo continuing education ..."

From September 21-24, 2003, Board Members Barbara Gaige and Michael Whiteman attended the Annual Conference of the National Association of Civilian Oversight of Law Enforcement (NACOLE) held in Los Angeles, California. The conference, entitled "Civilian Oversight: Tools for Success-Tools for Justice," featured workshops on force and excessive force; intelligence gathering, racial profiling, demonstrations, and First Amendment issues post 9/11; best practices and strategies to counter resistence to civilian oversight; basic tools for oversight of disciplinary cases; and interviewing witnesses and judging credibility. The conference also featured several panel presentations, including: mediation in oversight and insights on a serious police misconduct case - the Oakland "Riders."

At the Board's October 13, 2003 monthly meeting, Barbara Gaige and Michael Whiteman provided a report to the full Board about their experiences at the conference. Both Ms. Gaige and Mr. Whiteman reported that the conference was excellent and offered vast amounts of useful information. Mr. Whiteman urged the City to send members of the Office of Professional Standards as well as members of the Department's management to future conferences, and noted that it would also be valuable for members of the police officers union as well as the Corporation Counsel's Office to attend.

The Board's training program has resumed. Two training sessions have been scheduled for the first quarter of 2004.

COMPLAINT SUMMARIES AND STATISTICS

Section 42-340(C) of the City Code creating the Board charges the Board with providing "statistics and summaries of citizen complaints, including a comparison of the [Board's] findings with the final determinations of the [Police] Department."

During the fourth quarter, the Board received five (5) new complaints in addition to its sixteen (16) active complaints, seven (7) complaints that had been previously referred to mediation, three (3) complaints that were suspended from review in 2001 and one (1) complaint that was suspended from review in 2002. Monitors were appointed to all five (5) new complaints. Of the twenty-one (21) active complaints before the Board, the Board reviewed ten (10) complaints and rendered findings for all allegations contained in nine (9) of the ten (10) complaints. With respect to one (1) complaint, the Board had rendered a finding for only one (1) of the two (2) allegations contained in the complaint. The following is a summary of those complaints:

Complaint No. 50-02/OPS No. C02-420

Nature of Allegation(s): 1) <u>Failure to Engage Emergency Equipment Causing</u> <u>Collision</u> - a police officer failed to engage the emergency equipment on the officer's patrol car when the officer approached and attempted to pass the complainant's vehicle, thereby causing a collision;

> 2) <u>Improper Issuance of a Citation</u> - the officer improperly issued a ticket to the driver of the complainant's vehicle after the officer told the driver that a ticket would not be issued;

> 3) <u>Unjustifiable Withholding of a Driver's License</u> - the driver's license was withheld and not returned for several weeks; *and*

4) <u>Undue Delay in Furnishing Accident Report</u> - the complainant could not obtain a copy of the accident report for two months.

Other Board Actions/Requests/Recommendations

Recommendation for the Adoption and Implementation of a Bias-Based Policing Policy

In response to a complaint filed with the Board in May of 2001, Board members met with the Public Safety Commissioner, John Nielsen, in the first year to discuss its concerns about racial profiling and bias-based policing in the City of Albany. Pursuant to authority granted to it under the City Code, which provides that the Board "may make recommendations to the Common Council and the Mayor regarding police policies and practices...," the Board adopted Resolution 1 of 2001 recommending that steps be taken to limit, if not eliminate, the potential for bias-based policing and racial profiling in the City of Albany.

In May of 2002, the Commissioner, in correspondence to the Government Law Center, reported that Commander Paula Breen of the Albany Police Department had done extensive research and training on this issue, and had convened a series of working groups with interested community stakeholders and advocates to discuss the formation of such a policy. In October of 2003, the Board approved correspondence, drafted on its behalf by the Government Law Center, to the Commissioner requesting that the Department provide the Board with an update as to what the Albany Police Department has accomplished since the issuance of Resolution 1 of 2001 with respect to the adoption and implementation of a bias-based policing policy.

GOVERNMENT LAW CENTER

During the fourth quarter of 2003, the Government Law Center engaged in the following activities as directed by the local law and pursuant to its contractual obligations with the City of Albany:

- Drafted, and forwarded to the Board for its approval, the Board's third quarterly report for 2003.
- Drafted and forwarded correspondence to those complainants whose complaints had been referred to mediation, asking that they contact the Center to discuss the status of mediation.
- Drafted and forwarded correspondence to the Common Council and to the Mayor notifying them of the expiration of the terms of Board Members Marilyn Hammond, Judith Mazza, Michael Whiteman, and Paul Weafer; and requesting re-appointments for Board Members Hammond, Mazza, and Whiteman, and a new appointment to fill the vacancy to be left by Board Member Weafer.
- Drafted revised correspondence, for Board approval, to complainants notifying them of the outcome of the Board's deliberation of the investigation of their complaint and the findings rendered by the Board.
- Drafted correspondence, for Board approval, to the Commissioner of Public Safety following up on Board Resolution No. 1 of 2001 and the Board's recommendation for the adoption and implementation of a biasbased policing policy by the Albany Police Department.
- Drafted correspondence, for Board approval, to Complainant 1-01 in response to the complainant's request for documents relating to his complaint.
- Responded to a Freedom of Information Law (FOIL) Request from Council 82, which included preparing and forwarding a copy of the audio tape from the September 8, 2003 Board meeting to Council 82 President, Officer James Teller.
- Attended and participated in the Annual Conference of the National Association for Civilian Oversight of Law Enforcement.

- Met with Albany Law School's Computer Resources Department for a demonstration of software options to be used in the creation of a database for Board business.
- Updated the Board's Website to reflect additional links, the Board's fall/winter calendar of meetings, and most recent news articles.

In addition, the Center performed the following administrative tasks:

- Arranged logistics for and coordinated regular monthly meetings, including: securing dates, times and locations for each meeting, and providing notice to the affected parties and to the public;
- Prepared and assembled monthly meeting packets for Board members, including: photocopying complaints, reports, and accompanying documents for review;
- Prepared a summary of new complaints filed with the Board for presentation by the Chair of the Committee on Complaint Review at each monthly meeting;
- Reported all activities related to Board business at each monthly meeting;
- Recorded and transcribed the minutes of each monthly meeting;
- Notified affected parties of Board findings, recommendations, and requests following each monthly meeting;
- Provided content for, updated, and maintained the Board's Website;
- Conducted a monthly accounting and inventory of complaints filed with the Board, including a summary of active and closed complaints, recommendations, and pending requests submitted to the Commissioner of Public Safety, the Office of Professional Standards, and the Corporation Counsel's Office;
- Reported monthly complaint accounting and inventory to the Board at each of its fourth quarter meetings;
- Assisted with typing and forwarding the Board's requests and recommendations to the Commissioner of Public Safety; the Office of Professional Standards; and the Corporation Counsel's Office;
- Received and logged in complaints;
- Opened and closed complaint files;

- Maintained regular communications with Board members; and
- Answered inquiries from the community about the Board and the complaint review process.

The Board had an active fourth quarter, which included reviewing nearly half of its active complaints; attending the Annual NACOLE Conference; forming a new committee to handle Board policy recommendations and requests for policy review; and holding its monthly public meetings.
