Committee Chair Mike Grady was not present; no report was delivered.

Public Official Liaison

Committee Chair Mickey Bradley reported that there were no updates at this time.

Task Force on Monitors

Committee Chair Larry Becker reported that there were no updates at this time.

E. Elections for Committee / Task Force Elections

Chair Mickey Bradley informed Board members that are current Chairs of their respective committees to update him via email to provide their preference in the future to fill available committee positions.

F. Report from the Government Law Center (GLC)

Coordinator for the CPRB, Maureen Obie, reported that as of today, April 13, there are 13 active complaints. Of those, 3 were reviewed this evening, and 1 was closed with no review, leaving 9 complaints. A total of 723 complaints have been closed, including 40 complaints that have been closed with no review. The total number of complaints that remain suspended from review by the Board is 2. The total number of complaints filed to date is 741. Since the Board's last meeting on March 9, the GLC received 4 Grievance Forms, leaving the total number of forms received at 612. The Board's outreach to all individuals has resulted in 158 CPRB complaint forms received, or 25%.

Ms. Obie noted that a valued CPRB Research Assistant, Angela West, was in attendance. Ms. West a 3L student who will graduate next month. Ms. West was thanked for her hard work and commitment to CPRB initiatives during the past school year. CPRB Research Assistant, Elizabeth O'Reilly, has accepted an excellent summer internship with Millbank Law Firm, located in the Manhattan Financial District. Ms. O'Reilly was an invaluable asset to the Board during the last year. Both Ms. O'Reilly and Ms. West were congratulated for jobs well done and are wished the best of luck with their future endeavors.

The GLC is currently accepting applications for new CPRB Summer Research Assistant/s (either two part time, or one full time).

Ms. Obie reported that the GLC continues to conduct research internally and externally better options for data storage management. Information pertaining to other citizen police oversight organizations' administrative handling of complaints received from emotionally disturbed person (EDPs) nationally is also currently being researched.

The GLC will move forward on expanded outreach efforts proposed to the Board, including a postcard promo mailing, distribution of informational flyers, and increasing the number of complaint form locations, to include form locations that provide assistance to citizens with completing the forms.

Board member Zach Garafalo's reappointment by City of Albany Common Council for a first 3-year term is pending.

The Board's next monthly meeting is scheduled for Thursday, May 11, 2017, 6:00 p.m., at University at Albany Downtown Campus, in Milne Hall.

G. Report from the Office of Professional Standards (OPS)

Commander Michael Hicks reported that there were no updates at this time.

H. Report from the Chair

Chair Mickey Bradley noted that the date for the Board training is still to be determined. Additionally, specific topics for the training are yet to be determined. The event will be held on a Saturday in order to accommodate most members' work schedules.

Chair Bradley reported that the Executive Committee has met twice since the last CPRB meeting to discuss general housekeeping matters. Board member Veneilya Harden has been researching best practices for citizen police oversight groups' addressing emotionally disturbed persons as complainants. A meeting is scheduled for April 19 to discuss this topic with APD Office of Professional Standards.. All Board members are invited to attend the meeting along with Board member Veneilya Harden, Chair Mickey Bradley, and Coordinator Maureen Obie to explore all opportunities to address this topic.

Chair Bradley reported that he attended the induction of the new police officer class, and he was impressed at the new officers' interest and openness to learning more about the CPRB.

Vice-Chair Ivy Morris motioned to adjourn the meeting. Chair Mickey Bradley seconded that motion. The meeting was adjourned at 8:21 p.m.
